




# Policy Recommendation/Best Practice Model

## **Re-instating Sanctuary City legislation**

- Law Enforcement prohibited from inquiring about citizenship status of domestic violence and sexual assault cases.
- Enforcing Secretary of Housing and Urban Development's policy guidelines for emergency short-term shelter

".... Under the Order, for the protection of life and safety. Therefore, programs and services of this type that deliver in-kind services at the community level and do not condition the provision of assistance, the amount of assistance provided, or the cost of assistance provided on the individual recipient's income or resources are to make their programs available to all personals without verification of citizenship, nationality or immigration status, as set forth in the Order..."



## Policy Recommendation/Best Practice Model

#### **U-Visa Application Process Improvements:**

- Increasing the federal cap of U-Visa's provided yearly.
- Amending the stipulation that applicants must have arrived to the US via legal means.
